



## UPPER DARBY TOWNSHIP TRAFFIC CALMING: PETITION FORM

Once initial contact is made by specifically affected property owners inquiring about traffic calming and a public informational meeting and presentation is held to present background information, a petition shall be submitted to the Township signed by property owners from a minimum of **75% of the total number of generally affected properties** within the neighborhood boundaries determined by Township staff.

“Generally Affected” refers to all properties within a neighborhood area, the boundaries of which are determined by Township staff, petitioning for traffic calming including those adjacent to roads on which traffic calming features may not be located.

The purpose of obtaining signatures from owners of a minimum of 75% of the generally affected properties is to verify there are a significant number of residents interested in traffic calming before proceeding through the remainder of the traffic calming program.

Once this petition is completed and submitted to Upper Darby Township, the Township will proceed with the scheduling of traffic studies, develop a proposed traffic calming plan, hold a public meeting to disseminate information on proposed traffic calming plan, and vote for the proposed traffic calming policy.
